OFFICIAL RULES and PARTICIPATION AGREEMENT (“Official Rules”)

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED BY LAW. PARTICIPATION IN THE SWEEPSTAKES CONSTITUTES YOUR AGREEMENT TO BE BOUND BY THESE OFFICIAL RULES. Individuals who participate in the Sweepstakes or submit an entry are sometimes referred to herein as an “Entrant.”

1. SPONSOR: LA Clippers LLC (“Sponsor”).

2. SWEEPSTAKES ENTRY REGISTRATION PERIOD: There will be a total of four (4) Sweepstakes entry periods (each an “Entry Registration Period” and collectively, the “Entry Registration Periods”) as set forth below. For an Entrant’s submission to be eligible, the submission must be received during the applicable Entry Registration Period. 3. ELIGIBILITY: Sweepstakes is open only to individuals who are at least eighteen (18) years of age on the entry date, who are legal residents of California and whose primary residence is within a one-hundred fifty (150) mile radius of the city of Los Angeles, California (the “Sweepstakes Area”). There is a limit of one (1) Submission per person per Entry Registration Period and one (1) Bonus Submission per person during the Sweepstakes. Sponsor reserves the right to verify eligibility of all Entrants. The name of the “authorized account holder” associated with any given email address will be deemed to be the Entrant and must comply with these Official Rules. The authorized account holder is defined as the natural person who is assigned an email address by an Internet access provider, an online service provider, or another organization that is responsible for assigning email addresses or the domain associated with the submitted email address. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor’s satisfaction, the affected entry will be deemed ineligible. Submissions must be publicly viewable to be considered eligible. Making a Submission on Instagram during the Sweepstakes constitutes acknowledgement of and consent to these Official Rules. Subsequent attempts made by the same individual to submit multiple entries by using multiple or false contact information, accounts or otherwise may result in the Entrant being disqualified. Entries generated by a script, computer programs, macro, programmed, robotic or other automated means are void and may be disqualified. The parties acknowledge that the Sweepstakes evidences a transaction involving interstate commerce. Notwithstanding the provision in the preceding paragraph with respect to applicable substantive law, any arbitration conducted pursuant to the terms of this Agreement shall be governed by the Federal Arbitration Act (9 U.S.C., Secs. 1-16).

The parties shall maintain the confidential nature of the arbitration proceeding and the Award, including the Hearing, except as may be necessary to prepare for or conduct the arbitration hearing on the merits, or except as may be necessary in connection with a court application for a preliminary remedy, a judicial challenge to an Award or its enforcement, or unless otherwise required by law or judicial decision.
